When taking out a family tariff, up to four adults and max. eight children up to the age of 20 can be insured. They do not have to live in the same household. The family tariff applies for up to 10 people travelling together.

The insurance cover is subject to the currently valid General Insurance Conditions for the „PLUS RISK Extra Reise-Stornoversicherung II“.
